A Certificate of Insurance reflecting applicant's Comprehensive Liability to a minimum limit of \$100,000 one person, \$300,000 on occurrence Bodily Injury, \$50,000 property damage, shall be furnished to the district as a part of this application. The Certificate shall provide for ten days' notice to the District prior to a cancellation.

Contractor's Verification of bonding shall be furnished to the district as a part of the application.

A signed assurance of intent to pay prevailing wages on public works contracts is to be completed by the applicant and put on file with the District as part of this application.

All invoices submitted to the District for work done shall be accompanied by an Affidavit of Wages paid on Public Works Contracts, Department of Labor and Industries Form No. F700-007-000.

A copy of the applicant's statement of purpose, program and intent with respect to applicant's Affirmative Action Policy is to accompany and become a part of this application.

The District will make a good faith effort to contact each contractor on the Small Works Roster who had indicated an interest and ability to perform the type of work involved relative to each public works project whose cost is estimated to exceed seven thousand five hundred dollars, but not to exceed twenty thousand dollars.
